MITC Market Research Survey – We Have a Winner!



Thank you to everyone who took the time to complete the market research survey conducted by Adapt USA on behalf of MITC between March 7 and April 7. We sincerely appreciate your time and thoughtful responses. Results from this survey, along with findings during the next phase of focus groups and interviews, will be valuable as we look at future priorities and programs to best serve Maine's international business community.

Here are a few key survey findings:

- Respondents represented manufacturers (36%) and service providers (64%)
- Surveyed businesses are looking to expand beyond Maine - 42% nationally and 40% internationally - indicating growth aspirations for the next 2 years
- Top global target markets identified were the United Kingdom, Germany, France, China, Mexico, and Canada
- Significant barriers to international growth noted were regulatory hurdles, lack of market knowledge, trade policy and tariffs, logistics, limited capital, and workforce constraints

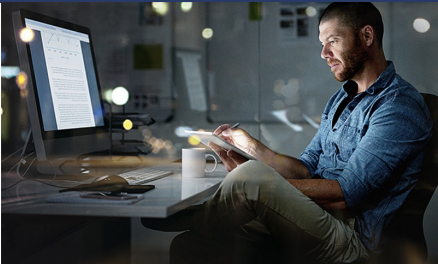

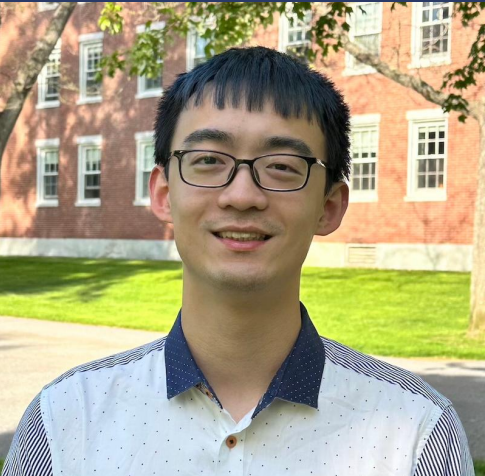
